^bEmissions from the X-622 and X-627 are based on the results of the most recent air emissions testing completed for each facility. The highest emissions of each nuclide were assumed to be emitted from each facility during each hour of operation for the facility in 2007. Emissions from the X-623 and X-624 are calculated based on influent and effluent sampling at each facility and annual throughput. Emissions from the X-326 are based on the mass of materials transferred within the glovebox, analytical data available for each material, and EPA emission factors.
